This report is not intended to be a full description of all activities but rather, provides highlights and information on the direction of our activities to keep the Board of Directors informed and to ensure adherence to the vision and guidance imparted to RAI-N by the GNSCCPA and its leadership. Throughout this period, RAI-N has maintained active and frequent communications with Ms. Allison Moore, Mr. Bruce Bracker and various other members of the Board of Directors in order to ensure that we have a fully coordinated approach to our efforts. RAI-N stands ready to address any issue, concern or suggestion that may arise from this report and from our ongoing dialogue with the leadership and the Board of Directors.

1. MARIPOSA COLD ROOMS PROJECT UPDATE

- Project is coming to a close!
- Finishing touches are being identified and addressed with General Services Administration (GSA).
- Planning is underway for the ribbon-cutting ceremony in April.

2. SUBMISSION OF CONGRESSIONALLY DIRECTED SPENDING REQUESTS

- In accordance with the priorities identified by the Board of Directors, the Port Authority submitted two projects for consideration under the program of Directed Funding Requests by the US Congress.
- The projects were submitted to the offices of Senator Mark Kelly and Congressman Juan Ciscomani.
- The two projects that were submitted were:
 - \$52 million funding request to pay for the modernization of the I-19 interchanges at Ruby Road and Rio Rico Drive
 - \$11.2 million funding request to pay for the modernization of the bridges over the Nogales Wash and the Railroad track at Calle Sonora, Produce Row and Gold Hill Road. Other bridges were considered at the request of the city of Nogales, but the Port Authority could not find any supporting documentation or cost estimates as are available for the three bridges in the request.
- As an example of the submissions, Attachment #1 provides a copy of the submission to Congressman Ciscomani's office.

3. LETTERS OF SUPPORT FOR SANTA CRUZ COUNTY DIRECTED SPENDING REQUESTS

- At the request of Santa Cruz County, the Port Authority issues letters of support for County projects that were submitted for consideration under the directed spending program.
- The letters indicated support for:
 - o The intersection at Calle Ramanote and the I-19 west Frontage Road;
 - o Ruby Road Bridge over Potrero Creek; and
 - Santa Cruz County Animal Shelter

4. ELECTRIC TRUCK CROSS-BORDER DRAYAGE PROGRAM

Planning continues for the Electric Truck Cross-border Drayage Pilot Program.

- Technical team has been in contact with the Texas Transportation Institute (TTI and the University of Arizona to see if they would be interested in partnering with the Port Authority to track, analyze and report on the various data sectors to determine the gains and challenges of the project.
- Notes from the February Meeting were distributed to the stakeholder group.

5. VISIT BY GOVERNOR'S OFFICE TO NOGALES



- On March 14, 2023, Marisol Flores-Aguirre, Director of the Southern Arizona Office for Governor Hobbs, and Kent Burbank, Director of Constituent Engagement, visited Nogales for several meetings on both sides of the border.
- The Port Authority hosted a meeting with the Board of Directors, Chairman Chamberlain provided a tour of his produce warehouse and distribution center, the County hosted a meeting at the County complex, Nogales Community Development provided a tour of their facilities and Supervisor Manny Ruiz hosted a meeting with the Nogales School District.
- Directors Flores-Aguirre and Burbank also visited the Kino Border Initiative. Special thanks to the US Consulate General in Nogales, Sonora for assisting in securing the

meeting with Kino Border Initiative.

- On February 16, the Port Authority, in collaboration with the Arizona Department of Transportation, the North American Development Bank, and the State of Sonora, hosted the first technical meeting for the Cross-border Electric Truck Drayage Pilot Program.
- With over 30 participants in this hybrid and presential meeting at the ASU Downtown campus in Phoenix, the process to identify the technical details and action items for the program, was discussed by all stakeholders.
- The Port Authority is working with stakeholders to prepare identify grant opportunities that can be sought and hopefully secured to help defray the cost of the program, estimated at approximately \$1.3 million.

8. SANTA CRUZ COUNTY PARTICIPATES IN MEETING WITH GOVERNOR HOBBS

10. HB2543 PASSES ARIZONA HOUSE OF REPRESENTATIVES

- As indicated in previous reports, the Arizona Legislature is considering HB2543, an appropriations bill that will provide \$330 million to fund transportation projects all over Arizona's 13 rural counties.
- As previously reported, this bill includes funding for four key projects in Santa Cruz County. The bill passed the House with a vote of 50 to 6.
- The bill now goes to the Senate where it will be part of hearings by the Transportation and Appropriations committees, and if passed, will then be voted by the entire Senate.

11. COMMENTS ON ADOT'S LONG-RANGE TRANSPORTATION PLAN

The I-19 interchanges at Ruby Road and Rio Rico Boulevard, along with the frontage roads on both sides of the freeway, in Nogales are in dire need of modernizing to accommodate for the growth in both commercial and residential traffic.

The I-19 interchanges at Ruby Road and Rio Rico Boulevard in Nogales are in dire need of modernizing to accommodate for the growth in both commercial and residential traffic. This is the perhaps the fastest growing area of Santa Cruz County and the congestion is leading to several safety concerns for the traveling public. Ruby Road is a nexus of both heavy commercial traffic that goes in and out of the dozens of produce warehouses and distribution centers in the area. It is also the key access intersection for residential and school traffic, leading to several safety concerns with the mixing of heavy traffic and cars.

These interchanges are essential for the movement of billions of pounds of fresh produce from Mexico that are essential to the nation's food safety and supply chain. It is also essential that, as residential growth continues, a safe environment be provided for the public that relies on these interchanges.

On behalf of the Greater Nogales Santa Cruz County Port Authority, I am writing to express our support fort the funding request by Santa Cruz County for the project that will modernize the intersection of Camino Ramanote and the West Frontage Road.

The Rio Rico area of Santa Cruz County is the county's fastest growing region and as such is facing several issues associated with growth. Congestion and safety on roads are probably the first and most noticeable repercussion and this project is designed to address one of those issues.

Authorities are reporting a high number of accidents at this intersection, and it is essential that the necessary and recommended improvements are made for the safety of the traveling public. At a cost of \$841,000, it is hard to imagine a similar project that will have a higher impact.

RE: Santa Cruz County Fiscal Year 2024 Community Funding Project Requests

Dear Congressman Grijalva:

On behalf of the Greater Nogales Santa Cruz County Port Authority, I am writing to express our support for the funding request presented by Santa Cruz County for the Community Funding Project requests to be included in the Fiscal Year 2024 Appropriations. These projects are critical to meeting our County's growing needs.

Our priorities are:

- Ruby Road Bridge over the Potrero Creek and Union Pacific Railroad \$3,600,000, THUD
 Appropriations Bill, Department of Transportation-Highway Infrastructure Projects Account –
 This project will replace the Ruby Road Bridge over Potrero Creek and create a grade separated
 crossing of the Union Pacific Railroad (UPRR) to improve safety and connectivity for this
 underserved community.
- West Frontage Road at Camino Ramanote Roundabout \$1,200,000, THUD Appropriations Bill, Department of Transportation-Highway Infrastructure Projects Account – In a proactive effort to reduce traffic accidents and observed congestion at this intersection, the County is planning on constructing a full roundabout.
- Santa Cruz County Animal Control Shelter \$1,500,000, Agriculture Appropriations Bill,
 HCFA Account The project consists of retrofitting an existing County Building (3,000 Sq.
 Ft.), for the purpose of converting it into a modern Animal Control Shelter with the capacity
 to effectively provide the highest level of animal services within the jurisdiction. The current
 shelter has surpassed its useful life to accommodate the shelter needs of the County.

Minutes from Electric Truck Pilot Program meeting

- Greater Nogales Santa Cruz County Port Authority will be the principal promoter and fiduciary agency for the pilot program.
- Initial estimates are that the pilot program will cost \$1.3 million (\$1 million for up to 4 (four) Semis, \$200,000 for two (2) high-speed charging stations, and \$100,000 for data monitoring and analysis.)
- The North American Development Bank (NADBank) has confirmed that they have set aside up to \$350,000 for a grant to be applied towards the cost of the pilot program.
 - o Requires a 20% match (\$70,000).
- ADOT EV Charging station funding may offer some possible funding towards this program.
- TEP, the local utility, has a program that includes the deployment of EV charging stations, but they had not considered trucks using this infrastructure.
 - o TEP looking into possible funding opportunities for the pilot program.
- Fresh Produce representatives indicate concerns over the ability for e-trucks to operate efficiently if they have a refrigerated unit with temperature-sensitive commodities.
 - Suggestion was made to consider focusing on dry-goods or manufactured products (non-temperature sensitive) for the pilot program.
 - o Consensus was that pilot should look at all types of commodities in order to identify challenges and solutions.
- Nikola indicated that they offer training for operators of their trucks.
 - Consider if ADOT safety inspection personnel will be required to participate in the training sessions to help them identify ways to modify safety inspection process for electric units.
 - Nikola indicated that their current models have a range of up to 350 miles, without a refrigerated unit.
 - Nikola is also looking at idle time for the truck as this will be one of the key challenges for cross-border operations in case trucks are forced to stay in a queue to cross the border.
- AZ Tech Council indicate that they have two additional e-truck manufacturers as members, and they offered to make an introduction to see if they are interested in participating in this program.
- Gerardo Arroyo of USAID indicated that there are a number of initiatives that will support net-zero emissions programs.
 - o Follow up with USAID is required to define how they can support this pilot program.

- Fresh Produce industry indicated that there are other types of truck usages that could also benefit from e-trucks, including local deliveries, that don't necessarily cross the border.
 Usually rely on smaller configuration trucks that travel 2 to 15 miles.
 - o AZ-Tech council members may fit this configuration.
- NADBank requires a proposal to be submitted for the grant that needs to include a scope of work for the pilot program.

Action Items:

- 1. Need cost information from:
 - a. ChargePoint on high-speed charging units
 - b. Nikola on truck costs
 - c. University of Arizona on data monitoring/analysis and reporting
- 2. Schedule next meeting in Ambos Nogales to start looking at possible sites for the installation of the charging units.
- 3. Technical team to prepare a draft scope of work that includes the information required by NADBank to be eligible for the technical grant.

Dear ADOT Team,

On behalf of the Greater Nogales Santa Cruz County Port Authority, here are comments from our community for you to consider as you develop the 2050 Long Range Transportation Plan.

Nogales is a community of approximately 25,000 residents, the entire county reaching 50,000 residents. Yet, for our community of our small stature, we have an outsized impact to the binational region, to Arizona and our nation.

In 2022, in northbound traffic, Nogales was the gateway for 370,773 trucks, 3,687,883 cars, 810 trains, and 9,883,250 people. This translates into just over 1,200 trucks, 10,100 cars and 27,000 people that cross into Nogales every day! When you include estimates for southbound traffic, that means that over 2,400 trucks, 20,000 cars and 54,000 additional people are relying on our roads, highways and overall infrastructure. These volumes are far more typical of a community that is many times our size. Therefor the wear and tear on our roads is far more than if you just look at our census. Can you imagine that each day, our ports of entry move twice the entire population of our city?

Some of the latest data indicates that the commercial traffic at Nogales, in all those trucks and trains exceeds more than \$29.5 billion in 2022. Considering that in 2010, that value was just over \$19.8 billion, that means that trade through Nogales has grown by 49% in just 12 years. Can you imagine what can happen between now and 2050? The importance of Nogales cannot be overstated.

That is why we are asking the Arizona Department of Transportation (ADOT) to look at Nogales and border communities through a different lens than the rest of the state. ADOT just completed the modernization of SR-189, a \$134 million project that is more akin to what people see in metropolitan areas like Tucson and Phoenix. But that is precisely the approach

and investments that our community needs to ensure the safety of the traveling public, that trade does not get bogged down by constant and growing congestion and that our community does not become the bottleneck for the Arizona-Mexico corridor.

The SR-189 project is part of a broader transportation strategy for our community and for Arizona. When the Mariposa port of entry was modernized, a \$250 million project that was completed in 2013, we gained a state-of-the-art facility that increased the design throughout capacity of the port from 400 trucks per day to over 4,000. But the trucks don't stop at the border; they take their products to warehouses and distribution centers all over our community, that is whey SR-189 was critical to get traffic to and from I-19 effectively, efficiently, and safely, but once on I-19, the vast majority of those trucks travel north to the Ruby Road interchange on I-19. This interchange is in desperate need of a major overhaul.

ADOT completed the Design Concept Report for the required improvements at Ruby Road and Rio Rico Drive interchanges in 2018. At that time, the estimated cost of the project was \$26.2 million. Given the recent impacts of inflation, aggravated by supply chain challenges, we estimate that these improvements have doubled in cost to some \$52.4 million – we would ask that ADOT update these numbers. Ruby Road and Rio Rico Boulevard, along with the frontage roads on both sides of the interstate, are critical to regional supply chains and the nation's food security.

Additionally, it is imperative that for our corridor to remain competitive, companies be offered multimodal transportation initiatives. That is why we are supporting the efforts of Santa Cruz County to design, build and operate a multimodal rail yard in the Rio Rico area to support the growing logistical needs of the manufacturing sector, the produce importers and distributors and the emergent mining sector in our region.

Mining alone stands to dramatically change the dynamics in our community. At full operation, the Hermosa Mine will add anywhere from 50 to 150 trucks to our roads, every day for the next 30 years or more. The ability to rely on rail for the movement of minerals offers a far more cost-effective means of transportation than trucks on roads. The impacts of the Hermosa Mine must be considered as you are undertaking this long-term planning effort.

Finally, the General Services Administration has recently begun the Feasibility Study process to modernize the DeConcini port of entry at downtown Nogales. The modernized facility promises to be a game changer for our entire downtown region, as well as for the retail, restaurant and tourism sectors in our community and appropriate planning must be considered to avoid the creation of new traffic bottlenecks in the connectivity to I-19 and Grand Avenue.

ADOT has been one of the most impactful partners in the growth of our binational community. There has been an understanding that our little community is heavyweight when it comes to trade, tourism, and the impacts to global supply chains. We hope that this approach remains a foundation for the long-term transportation planning process.
